

# INSTRUCTIONS, NOMINATION PROPOSAL AND ACCEPTANCE FORM TO SERVE ON THE SOGC BOARD OF DIRECTORS 2022-2023

The SOGC is pleased to announce the following vacancies, to be filled by election, for the SOGC Board of Directors 2022-2023 (current Board):

- One Ob/Gyn member from the Atlantic Region for one 3-year term, with option to stand for a second term;
- Two Ob/Gyn members from the Quebec Region for one 3-year term, with option to stand for a second term;
- One Ob/Gyn member from the West-BC Region for one 3-year term, with option to stand for a second term and
- One Family Physician for one 3-year term; with option to stand for a second term.

### **Eligibility criteria:**

- Knowledge of governance principles;
- Prior involvement with the SOGC such as service on committees, CME course development for a regional meeting or the Annual Clinical and Scientific Conference (ACSC), international work, etc. is preferable;
- The member should demonstrate the ability to think strategically, communicate effectively, and be diligent and conscientious in fulfilling her/his fiduciary duties;
- The member should exemplify positive leadership attributes, i.e. emotional intelligence, the ability to work collaboratively and engage in appropriate debate and discussion when needed, and possess a visionary and strategic drive and
- Preference will be given to members who are recognized leaders at any stage of their career, and have earned the respect of their colleagues.
