



SUMMARY OF BYLAW AMENDMENTS

Approved at the SOGC 2025 Annual General Meeting - June 17, 2025

This document summarizes the amendments approved by members. These changes are effective as of the AGM date but will be incorporated into the consolidated bylaws once formally signed.

<p>6.5 Term Limits</p> <p>(a) Subject to the provisions of this section, elected Directors cannot serve more than two (2) consecutive three-year terms;</p> <p>(b) Additional Directors cannot serve more than six (6) consecutive one-year terms</p> <p>(c) A Director who has left the Board for at least two (2) years, after having served for two consecutive three-year terms, may run again as if the person were sitting for the first time.</p>	<p>6.5 Term Limits</p> <p>(a) Subject to the provisions of this section, elected Directors cannot serve more than two (2) consecutive three-year terms;</p> <p>(b) Additional Directors cannot serve more than six (6) consecutive one-year terms</p> <p>(c) A Director who has left the Board for at least two (2) years, after having served for two consecutive three-year terms, may run again as if the person were sitting for the first time.</p> <p>(d) Notwithstanding the above, a Director elected to the role of President-Elect may serve beyond the six-year limit in order to complete their terms as President-Elect, President, and Immediate Past President.</p>
<p>8.2 Officer Positions and Terms</p> <p>(a) There shall be the following Officers: President, Immediate Past President, President Elect, Treasurer and two (2) Vice Presidents.</p> <p>(b) All Officer terms shall be for one year or until their successors are elected or appointed.</p> <p>(c) Provided they continue to be Directors, the President and Immediate Past President shall hold office for one year, as of right, in the year immediately following the year in which they hold the office of President -Elect and President respectively.</p>	<p>8.2 Officer Positions and Terms</p> <p>(a) There shall be the following Officers: President, Immediate Past President, President Elect, and Treasurer.</p> <p>(b) All Officer terms shall be for two years, except for the Treasurer, who shall serve a one-year term, or until their successors are elected or appointed.</p> <p>(c) Provided they continue to be Directors, the President shall hold office for two years, as of right, in the two years immediately following their term as President-Elect. The President-Elect shall serve for two years before assuming the office of President, and the Immediate Past President shall hold office for two years following their term as President.</p>

<p>8.3 Description of Office</p> <p>The Board may specify the duties of and, delegate to Officers, the power to manage the business and affairs of SOGC. The Officers shall have the following duties and powers, the details of which may be modified restricted or supplemented by the Board in SOGC policy:</p> <p>(a) President-When present, the President shall preside at all meetings of the Board of Directors, and of the Members, and shall ensure that the provisions of the Bylaw and policies are enforced. The President shall also be an ex-officio member of any Board committee and shall have such other duties and powers as the Board may specify.</p> <p>(b) President-Elect - If the President is absent or is unable or refuses to act, the President-Elect, shall, when present, preside at all meetings of the Board of Directors and of the Members. The President-Elect shall have such other duties and powers as the Board may specify.</p> <p>(c) Immediate Past President - The Immediate Past President shall have such duties and powers as the Board may specify.</p> <p>(d) Vice Presidents- The Vice Presidents shall have such duties and powers as the Board may specify.</p>	<p>8.3 Description of Office</p> <p>The Board may specify the duties of and, delegate to Officers, the power to manage the business and affairs of SOGC. The Officers shall have the following duties and powers, the details of which may be modified restricted or supplemented by the Board in SOGC policy:</p> <p>(a) President – The President shall serve as the Chair of the Board of Directors and, when present, shall preside at all meetings of the Board and of the Members. The President shall ensure that the provisions of the Bylaw and policies are enforced, shall be an ex-officio member of any Board committee, and shall have such other duties and powers as the Board may specify.</p> <p>(b) President-Elect - If the President is absent or is unable or refuses to act, the President-Elect, shall, when present, preside at all meetings of the Board of Directors and of the Members. The President-Elect shall have such other duties and powers as the Board may specify.</p> <p>(c) Immediate Past President - The Immediate Past President shall have such duties and powers as the Board may specify.</p>
