Reporting to the Chief Scientific Officer, the **Manager of Clinical Content and Research Development** will oversee staff, solve complex problems, seek funding opportunities, write compelling proposals, conduct literature reviews, and analyze evidence for the development of clinical guidance documents and accompanying resources.

The successful candidate will work closely with the Chief Scientific Officer to ensure the effective management of clinical and scientific content and contribute to the advancement of obstetric, gynaecologic and sexual and reproductive health care in Canada.

The role is critical in ensuring the organization's programs are managed effectively, funding opportunities are maximized, and clinical guidance documents, health care provider information and public information are based on the best available evidence.

- Prepare detailed reports and presentations summarizing research findings and recommendations.
